# Specifications:

Break out entire deck and re-pour with new decks. Install new Cool Deck/Sun Deck material over decks. \$55,000 (total pool deck, not section to right of pool).

Haul away all debris and prep for new decks. Pour decks with steel reinforcement dowelled into beam for a secure bond. All decks to be steel reinforced with #3 steel on full pattern. (not mesh material) Install all area drains or sloped drainage.

All plumbing and skimmers to be checked prior to pour. Any plumbing that needs to be redone or fixed after breakout to be an extra charge as needed. We have in house plumbers and will do these repairs at cost plus 20 %.

Note: Some plumbing may be unsalvageable during breakout, but it is unknowable until breakout.

Add concrete ramp and railing by entrance with sundeck covering. included

Re-pour in cantilever configuration with depth markers. Included

Remove and reinstall grab bars for exiting pool. Included

Re use depth markers as needed. If depth markers cannot be reused, provide new depth markers at material cost.

Remove old tile including tile band and toe tile and haul away trash: \$6,500

Install new tile on entire pool and install new tile band across pool and new toe tile.

Install new plaster: White Marble: )1 year warranty) \$14,500 or Upgraded Color plaster Pebble tech colored plaster same price for 6 year warranty. Pebble Tech 10 year warranty \$19,500 (color chosen by HOA reps)

Option: Cover concrete on right side with Sundeck to match other deck including \$5,800

Lead time: 1 week lead time to start. 6 to 8 weeks to complete project weather permitting.
