I.

II.

The purpose for which it is formed is to incorporate as a Civic Club for the property owners of Twin Barbors, "on Lake Livingston", to take title to and operate boat ramps, the swimning pool and all other land and facilities commonly held for the benefit of the property owners in the subdivision, to enforce restrictions, collect annual maintenance funds and be responsible for the maintenance of the subdivision as set out in the restrictions covering Twin Harbors, "on Lake Livingston" Subdivision and such other activity as is customarily done by Subdivision Civic Clubs.
