### **Financial Report:**

 Cliff reported the following amounts from our bank accounts as of the end of last month: the POA had \$15,575.25 in our checking account, \$31,762.33 in the special assessment account, \$33,456.36 in our money market account, \$5,139.36 in our 90-day CD account and \$1,000 in our 60-day CD account, for a grand total of \$86,933.30. A motion was made, seconded, and passed to accept the report.

### **Architect/Facilities Report:**

- A Building Permit was submitted by Ben and Cheryl Groner. A motion was made, seconded, and approved by the Board on the amended Building Permit. The amended permit insured that the roof drip line did not violate the five-foot rule from the adjacent property.
- A bid was submitted by CCC Blacktopping for asphalting the roads. A motion was made, seconded and approved to asphalt the following roads:
