#### Financial Report:

Cliff made a motion; it was seconded, and passed to accept the report.
- Cliff presented the budget that he and Ken Rychlik had worked on for the Annual Meeting. No changes were made.

# Architect/Facilities Report:

- It was recommended that the subdivision be mowed more often and that would be passed on to Barry Pounds.
- The Permit for Cynthia Blair was approved with the condition that the "trailer must be measured before being set up."
- Bids were received to fix the fence, tear down the main sign, and put up a new sign. The Board decided to let the new Architect/Facilities Committee handle it.
- The Board put on the agenda for the Annual Meeting the issues of lawsuits and Reserve's status.
